I assume full responsibility on behalf of said minor child, for bodily injury, death, loss of personal property, and expenses thereof;
- 3) In consideration of services to be received, the undersigned parent/guardian, for himself and his heirs and assigns, hereby releases Canyon Voyages Adventure Co. and its employees from any liability for claims or lawsuits brought by the undersigned, his heirs or assigns, and arising out of the activities provided by Canyon Voyages Adventure Co. EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES or others. I further understand that Canyon Voyages Adventure Co. reserves the right to refuse any person it judges to be incapable of meeting the rigors and requirements of participating in any river or land activities;
- 4) I understand that these activities are in remote wilderness areas and there is no immediate medical care available. Canyon Voyages Adventure Co. does not carry Epi pens or Epipheprine.
- 5) Canyon Voyages Adventure Co. does not provide cell phone service or satellite phone service;
- 6) The Venue of any dispute that may arise out of this agreement or otherwise between the parties to which Canyon Voyages Adventure Co. or its agents is a party shall be either the City of Moab, Utah Justice Court or the County or State Supreme Court in Grand County.
